ELEZIUN Spring, 2001

With the passing of RZ1: The Maricopan Elections, Already! Act, the official snowball of Maricopan democracy was put into full motion. Citizen Jeffrey Ragsdale of Houston, TX was on January 24 appointed by Military Governor John Minot as our provincial Secretary of State. Ragsdale received an unexpected gift when Gov. Minot put into force the failed Government Holiday Act for the province. Dec. 21-Jan. 1, May 30, Thanksgiving Weekend (Wed.-Sun.), and August 2-8 are the dates during which the SoS does not have to do any official business at all. However, Mr. Ragsdale will not be enforcing this legislation unless he deems it necessary.:)

On Saturday, February 17, the nomination forms for the upcoming election were posted, thus putting into motion for the first time in the history of Maricopa the mechanics of democracy!! Watch your mailboxes!

CG: Hallo to you too!

muc'häps: Chris, I cannot thank you enough for the generous offer you have made to all of us Talossans in regard to doing Talossan web pages. The time and resources invested in this are valued and appreciated!!

CG: Thank you, thank you, thank you!!

muc'häps: You're welcome!

muc'häps: 1. Let me first use the magic word: Pleeeeeeeease!!! :)

CG: Okey. :-)

muc'häps: 2. Aquamarine stands out as the leader and the original catalyst of the recent surge in provincial politics. Is that right?

CG: I'd like to think so. When I started Aquamarine, it was intended to be a way to revitalise the dying interest in provincial politics -- especially in MM. muc'häps: 3. Please tell the story of the founding of Aquamarine.

CG: In February of last year, I was sitting around, trying to figure out some way I could invigorate activity, provincial-wise, in Maritiimi-Maxhestic. I came up with idea of a political party; it still seems like a good start. You could even ask John Minot why he started the Roadrunner Party of Maricopa -- quite possibly for the same reason. The name "Aquamarine" came from my own birthstone -- March/Pisces. A little bit of arrogance on my part, but a unique name, wouldn't you say? Since then, Michael Pope and Phil Ledgerwood have joined actively, and I declared John Jahn a member -- if he doesn't say otherwise! :-)

CG: We can provide pride and leadership for those assigned to a province, while giving a voice to those Talossans who do not hold a seat in the Ziu or the Government.

CG: It seems that, given the increase of immigrants over recent years, that provincial politics is going to be a major focus eventually. Only so many people can fit into the national government, but provinces afford more people an opportunity to serve.

muc'häps: 6. Anything else that comes to mind!

CG: Go Yankees!

JEFF RAGSDALE:

An in-depth interview with our new provincial SoS

We sat down and spoke with Jeff Ragsdale, our new Maricopa SoS, on Monday, February 19, 2001. Like Chris Gruber, he impressed us with his candor, wit, intelligence, and humor. We at **muc'häps** rest easy knowing full well he is at the electoral helm!

muc'häps: Mr. Secretary, this is an exciting time for Maricopa!

JR: Indeed it is! Maricopa was formed from the Southwest Territories in 1996. For a while, it seemed that the road to full Organic certification would be quickly trod, but a computer catastrophe plus the rigors of non-RT schedules got in the way and derailed things for a great while. However, thanks to citizen Dale Morris, good work was done. Go to the [Unofficial Maricopa Home Page](#). When you do, make certain to save the web page as a HTML file on your hard drive or other storage medium. Remember, this is a Geocities page and, if I understand rightly, Geocities pages sometimes like to sprout wings and fly away. I avoid that company like the plague. Hopefully, my misgivings

about that company are way off-base.

muc'häps: Tell us more about this election.

JR: RZ1 will, for the time being, act as a de facto provisional constitution. The new administration will hopefully bring about new changes and a more-substantial document to tide us over during the journey to full Organic provincial certification. Look also at 97OrgLaw, Article XVI, Section 13. Unfortunately, we are far, far away from that lofty goal. It is my speculation as well as others that we would need at least twenty active Maricopans to really keep a fully-elected government and legislature functioning. Right now, we have seven to nine truly active people.

muc'häps: Just how historic is this election??

JR: As far as I can tell, this is the first time an attempt at full Maricopan democracy has ever gone this far. This is most likely the very first election ever held in the province of Maricopa!

muc'häps: When we talk about Maricopan history and her culture, what should we think about?

JR: Look at the [Unofficial Maricopan Home Page](#). That page says more in more eloquent terms than I could ever come up with.

muc'häps: To change to subject back a little, how long do you think we should expect for Maricopa to reach full Organic autonomy?

JR: If luck is on our side, two years. If not, five to ten. [It all depends on](#) how many new and active Maricopans come our way. Look to the [provincial website](#) on Maricopa to see where our citizens are assigned from.

muc'häps: Would you remain in Talossa that long? You're really here for the long haul,

aren't you??

JR: God willing, yes on both counts. Whether I would be SoS that long?? I don't know. I highly doubt it. Life is just too unpredictable to really make accurate predictions like that. Short-term, i.e. a year from now, I fully expect to be active in Talossa and in Maricopa. I also have every intention of remaining Maricopa's SoS for a long, long while!

muc'häps: Why did you become a Talossan?

JR: The idea of starting one's own country fascinated me. The article in the March, 2000 *Wired* magazine gave me the credibility I needed to make certain these Talossans were not just a bunch of web geeks like all the bug nations out there. The language is something I thought I would have gotten more into, but that has not happened yet. When I was first naturalized last summer, I never thought I would have been an MC (and then happily resign) so soon. I also never dreamed I would have been a provincial SoS!!

muc'häps: Would you ever support a Maricopan discussion forum?

JR: NO!!! Please remember, we are *Talossans* FIRST and Maricopans second!! With all the distance separating so much of us, particularly those in Cezembre and our Talossans in South America, we must have as much as we can scrape together to unite us. Wittenberg does just that. I can tell you now that if provincial life starts to edge out our unified national consciousness, I will quit the provincial scene in a heartbeat. I joined *Talossa*. Maricopa and all the fun it has given me so far is but ancilliary icing on the cake.

muc'häps: You are very active in the RCT.

JR: Yes, I am. However, I do not have any desire to inject national politics into the provincial Maricopan scene. The political vision I have for Maricopa is the exact opposite of what now exists in Maritiimi-Maxhestic: a situation where national and provincial politics are seamless. A very successful situation for that province, I might add!! More power to them!!!

muc'häps: Oho!! Methinks I hear a wee bit of ambition in your tone, Mr. Secretary;))!

JR: Get your MiracleEar fixed;). I have no desire to and I will not seek the office of Governor or Governor-Designate now or at any time in the near future. I would not mind being Senator someday, though. But that is way down the line.


muc'häps: To get back to the business at hand, what dates should we watch for?

JR: March 15 is the date all nominations must be physically in my hand!!! To give everyone a level playing field, remember that only snail-mailed completed nomination forms are acceptable. Absolutely no emailed nominations or nominations made by proxy transmitted by any means will be accepted. If we are unable to get a mailing address for Pete Hottelet, I may be forced to make an exception for him. I will mail out the official ballots no later than March 17. The voted ballots must be in my hands no later than April 21. IF I GET YOUR BALLOT ON APRIL 22, IT WILL NOT COUNT!!!:) April 21 is the absolute drop-dead last day I can close the polls and still be in compliance with RZ1. Write-in votes will be allowed and the election will be open ballot like the national ones are already.

muc'häps: If someone wanted to see a tangible result of Maricopan contributions to Talossa, what could one look for??

JR: Albrec'ht Stolfi and Paola Cleri have been major contributors to the [Cezembrian Arts Centre](#). It's not *all* about politics, you know.:)

muc'häps: Mr. Secretary, thank you so much for taking the time to be with us today!


JR: With the increase in the number of our citizens, provincial politics will give more people places to be leaders and serve! Thank you for having me!

The Maricopan Elections Already! Act
uréu q'estrada sã: John Minot, PC-Maricopa

WHEREAS, the glorious province of Maricopa has too long been languishing under the dreaded specter of Apathy, and

WHEREAS, the voting pool being half a dozen at best, a viable, representative government of the type needed for certification is a good while away, but

WHEREAS, for a later, certifiable government to ever endure it must have forerunners to get its citizens "in the mood," and

WHEREAS, any accountability regarding its governor should be a welcome change from the current system, and

WHEREAS, it is understood that the following legislation will not give the province of Maricopa official certification,

THEREFORE:


I. The Ziu provisionally relinquishes its right to appoint the Military Governor to the uncertified province of Maricopa, who will henceforth be democratically chosen. But who will, until a further change in the law, shall have the same powers as before, except he-she will be democratically elected.

II. The Military Governor is ordered to appoint a Secretary of State for Maricopa, who will facilitate elections for the Governor's post by the following criteria:

- a. The polls shall be open for exactly one month, and shall open, at most, two months after the passage of this bill.
- b. At the point that the polls open, the Secretary of State shall have collected nominations from all contenders and provided them with a list of electronic and postal addresses of Maricopa's reachable citizens.
- c. The receiver of the majority of votes cast (with later runoffs, if no candidate receives a majority), shall assume office on the final closing of the polls. Assuming no runoff, the new Governor shall take office on April 22, 2001.
- d. The post of Governor and Senator of Maricopa shall not be held simultaneously by one person.

III. In all Maricopan gubernatorial elections following this one, the same procedure shall be followed, and the winner of the next election shall assume office at least four months and at most five months after the winner of the coming election did.


IV. The Governor of Maricopa will continue to rule in the same fashion as previously, and may be reelected.

V. The Governor of Maricopa shall name a Governor-Designate. Should the Governor resign or die in office, the Designate shall become Governor, and has the choice to declare immediate elections or serve out the rest of the Governor's term.. 



THE FULL TEXT OF 97OrgLaw, ARTICLE XVI: SECTION 13 Art. XVI: Sec. 13.

No province existing at the time of the adoption of this Organic Law may avail itself of any right guaranteed in this Organic Law until such time as the province contains within it a working constitution with an elected government and a citizenry comprising at least

10% of the population of the Kingdom of Talossa or at least five persons (whichever is more). The Ziu shall have power to certify this by appropriate legislation.

müc'häps: Tell us more about *Pëschat*.

CG: I plan to have *Pëschat* fill the rôle of "the Talossan pop culture mag" that was originally filled by my own Vénéneux. I accept contributions from any Talossan who wishes to contribute, but instead of a mere reporting rag, we plan to be a more intellectual dissection of who, what, when, where, and especially why. Why are Talossans the way they are? Why do we argue so much? Why are we different from the rest of the world?

müc'häps: What does the word mean?

CG: Heh. That's my little secret. Although, I would prefer if any Talossan out there who actually knows, would they mind keeping it a secret, at least until those who don't know acquire a copy of the dictionary? Thanks.

müc'häps: What will this new mag be all about?

CG: About five articles long. :-)

müc'häps: What are the underlying things you think about in web design, construction,

and the like?

CG: I try to stick to my personal design philosophy of consistency, simplicity, and style. Consistency is essential throughout a site, so as not to throw too many visual items at the average web surfer. Just like offline materials, you try to make the business cards match the letterhead match the brochures, and so on.

Simplicity is essential, because it requires proper use of whitespace (or blackspace, bluespace, redspace, whichever is the background colour) to separate visual elements. The human eye gets tired after a while and whitespace gives that eye a place of rest. Simplicity also helps me keep out any nonessential items, like silly JavaScripts or anything else that might get in the way of the enjoyment of the site.

Style is based on my personal tastes. Lately, I've been immersing myself in the study of what I call "retronomics": I love the style and design of the Art Deco movement, and of the 20s-40s in general. You may have noticed my use of certain retro fonts.

müc'häps: How do you come up with all those schnazzy color schemes? It seems pastels and "powder" colors are in in your boat. Are they the going thing in web circles now?

CG: My favourite colours tend to pop up quite a bit, indeed, in these sites (blue is a biggy for me), but I tend to use colour schemes that properly reflect the subject matter. For instance, with the muchaps site, I used colours from the Maricopan flag. The tan for the background comes from the image invoked in my head when I think of the southwest: desert. John Minot's Roadrunner Party page uses that same imagery.

As far as pastels being a big web thing, I'm not sure. I use them because it's much easier on the eye to read text off a pastel background than a brighter colour. Test it yourself. Create an HTML document using red as the background colour and then tell me if your eyes don't ache.

müc'häps: What software do you use exactly?

CG: I use Macromedia Dreamweaver UltraDev (like my pals Phil and Tomás ;-)) for the site design and management; Macromedia Fireworks, Microsoft Image Composer, Adobe Photoshop, and Adobe ImageReady for graphic design and optimisation; the operating systems are MS Windows 2000 Professional and Windows ME; and I tend to draw the ideas out in a notebook I use.

müc'häps: What computer have you?

CG: A 550 MHz Pentium III with 128 MB RAM, a Voodoo 3 3000 video card, two 15 GB hard drives, a CD-ROM drive, a Zip drive, a Network Interface Card, a 56k dialup modem, and a Yamaha onboard soundcard. If you understand any of that, then you're a nerd. ;-)

müc'häps: Thank you again!

CG: Thank you.

The Maricopan Elections Already! Act
uréu q'estrada sâ: John Minot, PC-Maricopa

WHEREAS, the glorious province of Maricopa has too long been languishing under the dreaded specter of Apathy, and

WHEREAS, the voting pool being half a dozen at best, a viable, representative government of the type needed for certification is a good while away, but

WHEREAS, for a later, certifiable government to ever endure it must have forerunners to get its citizens "in the mood," and

WHEREAS, any accountability regarding its governor should be a welcome change from the current system, and

WHEREAS, it is understood that the following legislation will not give the province of Maricopa official certification,

THEREFORE:

I. The Ziu provisionally relinquishes its right to appoint the Military Governor to the uncertified province of Maricopa, who will henceforth be democratically chosen. But who will, until a further change in the law, shall have the same powers as before, except he-she will be democratically elected.


II. The Military Governor is ordered to appoint a Secretary of State for Maricopa, who will facilitate elections for the Governor's post by the following criteria:

- a. The polls shall be open for exactly one month, and shall open, at most, two months after the passage of this bill.
- b. At the point that the polls open, the Secretary of State shall have collected nominations from all contenders and provided them with a list of electronic and postal addresses of Maricopa's reachable citizens.
- c. The receiver of the majority of votes cast (with later runoffs, if no candidate receives a majority), shall assume office on the final closing of the polls. Assuming no runoff, the new Govenor shall take office on April 22, 2001.

d. The post of Governor and Senator of Maricopa shall not be held simultaneously by one person.


III. In all Maricopan gubernatorial elections following this one, the same procedure shall be followed, and the winner of the next election shall assume office at least four months and at most five months after the winner of the coming election did.

IV. The Governor of Maricopa will continue to rule in the same fashion as previously, and may be reelected.

V. The Governor of Maricopa shall name a Governor-Designate. Should the Governor resign or die in office, the Designate shall become Governor, and has the choice to declare immediate elections or serve out the rest of the Governor's term.. 



THE FULL TEXT OF 97OrgLaw, ARTICLE XVI: SECTION 13 Art. XVI: Sec. 13.

No province existing at the time of the adoption of this Organic Law may avail itself of any right guaranteed in this Organic Law until such time as the province contains within it a working constitution with an elected government and a citizenry comprising at least 10% of the population of the Kingdom of Talossa or at least five persons (whichever is more). The Ziu shall have power to certify this by appropriate legislation.

ELEZIUN Spring, 2001 update: an in-depth interview with Maricopan Secretary of State Jeff Ragsdale

JR: Not including Pete Hottelet, for whom we still have no contact info, we have in Maricopa nine active citizens. To this point, John Minot has received four votes (from Jeff Ragsdale, John Minot himself, Ken Oplinger, and Gary Schwichtenberg). While the opportunity for write-in votes has been extended, no one has cast any write-in votes. RON, the Legend: The Premier of Vuode Province talks about Talossa!

We sat down and spoke at length with him. This interview was conducted in a series of emails from 27 February, 2001 to 4 March, 2001.

> Can you elaborate more on what Bill Cooper is doing for Voude?

RR- Bill is working on VPR-SOG issues and providing me with a grounded, common-sense sounding board. His addy is: bcooper@ccrtc.com

> What is your take on provincial politics in general and in Voude in particular?

RR- Excellent question, Jeff!

Many Talossans welcome the awakening Provincial scene because it encourages involvement in Talossan politics for those who don't want to play on the national scene, yet still have a voice in most matters.

>The 97OrgLaw takes in most of the obvious powers, i. e., things government controls such as weights, measures, etc. What not-so-obvious things could our provinces do for our citizenry?

RR- It would allow a unique cultural flavor to form in each Province. The Vuode Province citizenry would be known for one thing and Aquamarine citizens, for another.

> What plans have you for Vuode?

RR- Aside from our bringing our platform and mission statement to fruition, we intend to make Vuode the epitome of function and stability in government. Vuode Province will set an example for all to follow.

> And what are your platform and mission statement??

RR- 1) To examine, dissolve and rewrite the Vuode Province constitution.

2) To examine and propose changes the current Vuode Province political system.

3) To prepare Vuode Province for a functional future.

4) To investigate the ramifications of provincial certification and its effect on Vuode's inter-provincial relations.

5) To examine, create and implement a Vuode Province Lower Cort.

> Why do we need inter-provincial relations? Are we all one country, united, and indivisible?

RR- I wouldn't think of this in the same light as a "UN-type" alliance, Jeff. Many great minds are better than one and with the creation of the VPR-SOG, Provincial SoS's, Premiers or their equivalents and citizens can find common issues to study, discuss and possibly implement locally.

> What constitutional ideas are floating about your mind?

RR- Until I get a copy of the Vuode Constitution, I can't go into great detail, but establishing a Provincial Judiciary, a Parliamentary government and Having our SoS taking an active role in inter-provincial relations are my top three goals right now.

This allows many important undertakings to occur simultaneously. Remember, the VPUP's role is to bring function back to Vuode Province. "A Strong Province For A Strong Nation - VPUP!" ;-}

> Where do you see Talossa in ten years?

RR- In ten years, our language will be spoken by many, our population will be over one-thousand, and the Provinces will be much more influential....

> How on earth is this massive going to be achieved? With the Netscape and Wired magazine publicity, not to mention our stature in the micronational world up until three years ago, why haven't we had this influx of people already?

Stolfi Founds Institute of Technology

Albrec'ht Stolfi announced on Wittenberg, April 10, the creation of the Royal Maricopan Institute of Technology, or Institueu Maricopán Rexhitál da Tec'hnoioxhà. Stolfi claimed the RMIT will function as "a Talossan equivalent of MIT", where Talossans and Cestoûrs alike may pursue undergraduate and graduate studies in several fields of engineering and science. English uses possessives and prepositions rather than cases, such as "to" or "-s". Rather, the subjunctive goes on verbs. I have a little bit of recent experience with it. English technically has one, but it has

died out except among pompous writers, such as occasionally myself:

If there _be_ any bodies buried, nobody's dug them up. _Had_ I an idea, I'd tell you.

Thanks again, John, for your insights!

WHEREAS, the glorious province of Maricopa has too long been languishing under the dreaded specter of Apathy, and

WHEREAS, the voting pool being half a dozen at best, a viable, representative government of the type needed for certification is a good while away, but

WHEREAS, for a later, certifiable government to ever endure it must have forerunners to get its citizens "in the mood," and

WHEREAS, any accountability regarding its governor should be a welcome change from the current system, and

WHEREAS, it is understood that the following legislation will not give the province of Maricopa official certification,

THEREFORE:

I. The Ziu provisionally relinquishes its right to appoint the Military Governor to the uncertified province of Maricopa, who will henceforth be democratically chosen. But who will, until a further change in the law, shall have the same powers as before, except he-she will be democratically elected.

II. The Military Governor is ordered to appoint a Secretary of State for Maricopa, who will facilitate elections for the Governor's post by the following criteria:

- a. The polls shall be open for exactly one month, and shall open, at most, two months after the passage of this bill.
- b. At the point that the polls open, the Secretary of State shall have collected nominations from all contenders and provided them with a list of electronic and postal addresses of Maricopa's reachable citizens.
- c. The receiver of the majority of votes cast (with later runoffs, if no candidate receives a majority), shall assume office on the final closing of the polls. Assuming no runoff, the new Governor shall take office on April 22, 2001.
- d. The post of Governor and Senator of Maricopa shall not be held simultaneously by one person.

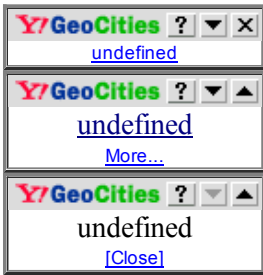
III. In all Maricopan gubernatorial elections following this one, the same procedure shall be followed, and the winner of the next election shall assume office at least four months and at most five months after the winner of the coming election did.

IV. The Governor of Maricopa will continue to rule in the same fashion as previously, and may be reelected.

V. The Governor of Maricopa shall name a Governor-Designate. Should the Governor resign or die in office, the Designate shall become Governor, and has the choice to declare immediate elections or serve out the rest of the Governor's term.

THE FULL TEXT OF 97OrgLaw, ARTICLE XVI: SECTION 13

No province existing at the time of the adoption of this Organic Law may avail itself of any right guaranteed in this Organic Law until such time as the province contains within it a working constitution with an elected government and a citizenry comprising at least 10% of the population of the Kingdom of Talossa or at least five persons (whichever is more). Tha-tha-that's All Folks!

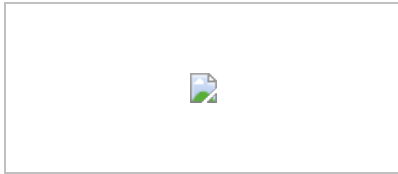
Yes, this issue of *Müc'häps* has been especially brief and lacking in content. Please understand that not only has

WHEREAS, any accountability regarding its governor should be a welcome change from the
current system, and
WHEREAS, it is understood that the following legislation will not give the province of
Maricopa official certification,

THEREFORE:

- I. The Ziu provisionally relinquishes its right to appoint the Military Governor to the uncertified province of Maricopa, who will henceforth be democratically chosen.
But who will, until a further change in the law, shall have the same powers as before, except he-she will be democratically elected.
- II. The Military Governor is ordered to appoint a Secretary of State for Maricopa, who will facilitate elections for the Governor's post by the following criteria:
 - a. The polls shall be open for exactly one month, and shall open, at most, two months after the passage of this bill.
 - b. At the point that the polls open, the Secretary of State shall have collected nominations from all contenders and provided them with a list of electronic and postal addresses of Maricopa's reachable citizens.
 - c. The receiver of the majority of votes cast (with later runoffs, if no candidate receives a majority), shall assume office on the final closing of the polls.
Assuming no runoff, the new Governor shall take office on April 22, 2001.
 - d. The post of Governor and Senator of Maricopa shall not be held simultaneously by one person.
- III. In all Maricopan gubernatorial elections following this one, the same procedure shall be followed, and the winner of the next election shall assume office at least four months and at most five months after the winner of the coming election did.

IV. The Governor of Maricopa will continue to rule in the same fashion as previously, and may be reelected.

V. The Governor of Maricopa shall name a Governor-Designate. Should the Governor resign or die in office, the Designate shall become Governor, and has the choice to declare immediate elections or serve out the rest of the Governor's term.

THE FULL TEXT OF 97OrgLaw, ARTICLE XVI: SECTION 13

Art. XVI: Sec. 13. No province existing at the time of the adoption of this Organic Law may avail itself of any right guaranteed in this Organic Law until such time as the province contains within it a working constitution with an elected government and a citizenry comprising at least 10% of the population of the Kingdom of Talossa or at least five persons (whichever is more). The Ziu shall have power to certify this by appropriate legislation.

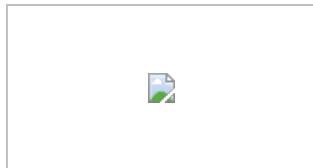

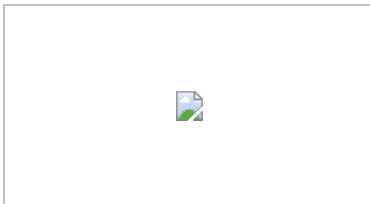

The 29th Ziu ~~a retrospective~~ and a General election preview

A special prayer and my heart and the hearts and prayers of all Talossans as well as all civilized people worldwide go to the wife and unborn child as well as other family and friends of Daniel Pearl, the South Asia bureau chief for the Wall Street Journal, whose murder at the hands of looney muslim extremists in Pakistan has just been confirmed. Wearing my hat for just a brief moment as Editor-in-Chief of mûc'häps!, mûc'häps! condemns this atrocity and demands justice be brought down on the scum who did this to an innocent civilian.

Pope Jahn XXIII, September 11, the currently ongoing Senatorial election in Florencia, and the Witt 8 crash on November 9 have made this 29th Ziu (which was the 32nd until Martin-Pierre Frenette found where the numbering had gone awry) unexpectedly eventful, indeed, one of the seminal Zius in the history of Talossa. WHEREAS the perpetrators of these attacks are avowed followers or coordinated by the mass murdering terrorist Osama Bin Laden.

THEREFORE the ZIU resolves the following:

APPLAUDS the heroic and successful efforts of the passengers on board the airliner that crashed in Pennsylvania for preventing the hijackers from carrying out further senseless violence and destruction of innocent human life.

APPROVES any and all actions taken by the Government of the United States of America to retaliate against and punish the perpetrators of these despicable crimes against humanity.

SENDS Talossa's Invincible Moral Support to both the rescue and recovery operations in progress in Washington and New York, as well as for all future operations taken to retaliate against the terrorists.

ENCOURAGES the Government of the USA to wage a war not just on the perpetrators and plotters of these particular crimes, but against all terrorists of this planet.

ASKS the Government of the United States of America to unchain it's different intelligence organizations in order to have them better prepared against future attacks on civiled society.

SUPPORTS the NATO members' (and other civilized countries) decisions to support the United States.

ENCOURAGES future cooperation amongst these countries in order to protect freedom, peace and Western Civilisation as a whole.

DENOUNCES all the anti-Western terrorists of this planet, as well as any countries harboring them and offering them bases of operation.

This bill passed with 17 përs, no contrâs, and 2 abstentions, there being but 19 people in Cosâ at this time.

RZ4 - The Clear Message Act

Uréu q'estadra sã: Maxime Paquin-Charbonneau - (Senator-Florenciâ)

Whereas our capitalism system is not the best, but it still better here then in Kaboul
Whereas we have the right to live our life in peace

Therefore, I ask the Ziu to send a clear message to President Bush, kick the ass of this Terrorist, and start to give a place in the world to everybody. Mr Bush we trust you to protect our life... but we ask you to change your policy in order to create the paradis on earth...

RZ4 did not pass the Ziu (3 përs, 10 contrâs, and a suprising 6 abstentions--this bill was a contentious issue) The reason was disagreement over the phrase "but we ask you to change your policy in order to create the paradis on earth" as it, to my mind, at least came off as totally left-wing and sought to place blame at the doorstep of the United States and the West instead of squarely and solely on the shoulders of the terrorists. The contraversy between Maxime and the rest of Talossa is at the heart of what has made the Florencian Senate race so heated. Had Maxime simply remained silent or had agreed with the rest of us, John Eiffler might not have been inspired to run for the Senats in the first place.

From the November, 2001 Clark came a bill which, in most any other Ziu in most any other time, would have gotten top billing from politcal pundits like I: RZ7 - The Immigration Progress Act. Proposed and written by Ben Madison, this legislation was passed by the Ziu and implements a "stair-step" immigration process whereby full citizenship (voting in the General Election being the main benefit) is not granted right away, but the newly-minted Permanent Resident can get his feet wet in Talossan discussion, politics, and provincial matters far faster than with the old system.

Ben won approval with his bill via a "sunset clause" which kicks in after the fifth Permanent Resident or the publication of the 2nd Clark of the 33rd Cosa (or is it the 30th Cosa??), whichever comes first. So far, Thomas Cutterham of England and Garth Spencer of Vancouver, British Columbia have become Permanent Residents. Garth has become a very frequent poster on Witt while Thomas seems to have disappeared for now.

In the Clark for December, 2001, RZ9 - The Make Thomas II our first Permanent Resident Act, was approved and Talossan history was made. In the January, 2002 Clark, a little more history was made in the passage of RZ11 - The make Garth Spencer our second permanent resident act. The final Clark of this Ziu, February, 2002, would have been devoid of any bills but for John Jahn's RZ13 - The Talossan Consulate Act, a bill which gives an official designation to Ben and Amy's house which sits outside of Talossa proper.

There were no bills in this Ziu which did not have any real purpose other than inflate the ego of the proposer. No bill was filled with fluff only.

The 29th Ziu was also significant in that it was the first full Ziu in the post-Talossan-Liberal-Party era which began when six now-former Talossans renounced their citizenships at roughly the same time in the Spring and early Summer of 2001 -- a devastating blow to the Talossan Opposition which showed up in a convincing victory for the Progressive Conservatives in this election.

The election in Florencia is significant, like all Senate elections, in that 1/7 of the voting power of the Senats is at stake. However, whichever way the election goes, the Progressive Conservatives will still control 4/7 of this body and, if John Eiffler wins, will have 5 of the seven seats.

At this writing, it seems that Maxime Charbonneau will not be re-elected to the Senats. While he says his time in the Ziu is done, I say he will be in Cosa in this next term. If that is true, then Jeff Ragsdale will, for the first time, probably hold a Cosa seat for a party other than the RCT. Jeff made a little wave of his own when he defected from the RCT and Opposition back in September to become a PC supporter. His vote and that of the 39 other voters who cast their ballots in the previous election was worth a full half-Cosa-seat. This one action by him will be consummated when he votes PC for the first time in the upcoming election and, if turnout is as it was the last time around, it could swing another seat in Cosa to the Progressive Conservatives.

Once again, the Opposition goes into election having no real and substantive reason to give voters for them to put the RCT and ZPT into power. It seems to me that an RCT/ZPT coalition is the only way for Opposition to gain Government at any time in

the foreseeable future. And who would they run as their Prime Ministerial candidate?? Ken Oplinger? Too inactive. Ron Rosalez? Too "out there", perhaps. Besides, real life has him away from Talossa for a good while yet. Maxime P-Charbonneau?? Nope for obvious reasons. The Opp's best candidate for Prime Minister is, at this point, David Fauteaux, currently our Secretary of State, and as loyal and patriotic a Talossan as one will ever find. When Jeff Ragsdale felt his being in the RCT was no longer something he could live with, Dave showed great class and dignity in his handling of the situation and gave Ragsdale all his support and friendship. As Jeff said one time, "Dave is a class act. If he was Prime Minister, I would sleep well."

Look for the Progressive Conservatives to win 13 seats in Cosa. The RCT will drop to 4, and the ZPT will keep its 3. Look for the party faithful, both member and ardent supporters to vote normally. Look for the critical swing vote to go to the PC in waves! Michael Pope will be Prime Minister once again.

Had the Liberals, RCT, and ZPT been more willing in these areas to compromise, the PC might be out of business as a governing political organization and Kenneth Oplinger might be Prime Minister today. But that is another long guest commentary for another time.

What can the Opposition do now ?? Well, they are in a good spot in that the election has not yet begun. Yea, even the campaign season has not yet come to pass. Argue hard and come together as a group. Coalition? It's the only way for the Opposition to have any real hope of defeating the PC. But even with an Opposition love fest, the PC base of die-hards and pocket votes will carry the day.

This election, at least.
